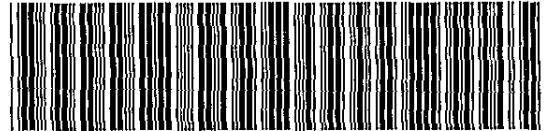

We the undersigned natural persons of the age of eighteen years or more, at least two of whom are citizens of the State of Florida, acting as incorporators of a corporation under the Florida Non-Profit Corporation Act, Do hereby adopt the following Articles of Incorporation for such corporation

Article One

The name of the corporation is **Without Walls, Tallahassee Worship Center, Inc..**

Article Two
