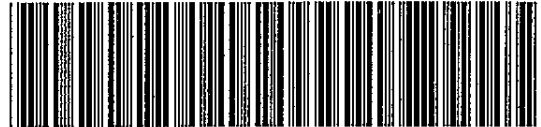

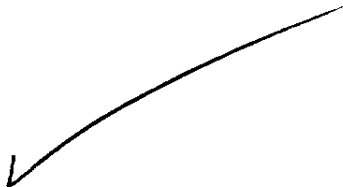

## ARTICLE I NAME

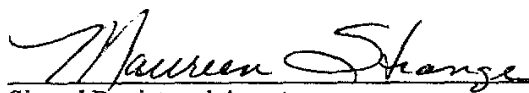

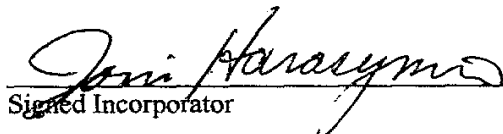
