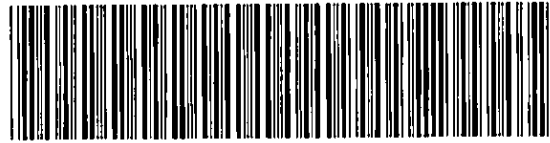

ARTICLE IX – DISTRIBUTIONS ON LIQUIDATION OR DISSOLUTION – AMENDED 21 MARCH 2023

In the event of the dissolution of this corporation at any time for any reason, all of the assets of the corporation shall be given or contributed to one or more corporations, associations, entities or institutions which are wholly of a public and nonprofit nature, which are organized exclusively for religious, charitable, scientific, or educational purposes, and which shall at that time qualify as an

exempt organization or organizations under Sections 501(C) (3) and 170 (C) (2) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future United States Internal Revenue Law), and any such contributions shall be made to such corporation, association, entity, and/or Institution as may be determined by the Directors.


