ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation pursuant to chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

**ARTICLE I NAME**

The name of this non-profit corporation shall be: Apostle Faith Church of Miracles, Inc.

**ARTICLE II PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS**

The principal place of business of this corporation shall be: 2301 NW 119th Street; building 2-316; Miami, Florida 33167. The mailing address of this corporation shall be Post Office Box 470947; Miami, Florida 33247.

**ARTICLE III THE SPECIFIC PURPOSES OF THIS NON-STOCK, NON-PROFIT CORPORATION ARE:**

1. To fulfill the great commission as commanded by our Lord and Savior Jesus Christ according to Saint Matthew, Chapter 28:12-20.
2. To intermingle with the various minority communities in an effort to present an alternative way of life through various means, i.e. performing arts, Word of God and audio visual aids, for rehabilitation and constructive motivation. A Christian fellowship area for the specific purpose of Biblical counseling and encouraging spiritual and mental growth.
3. To work cooperatively with local churches as an evangelistic outreach.
4. to provide community based services for the elderly, handicapped, infirmed and youth of the community.

5. The general purposes and powers of the corporation are to have and exercise all rights and powers conferred on non-profit corporations under the laws of Florida, including the power to purchase, acquire, administrate and use real and personal property of every kind to accomplish the charitable and religious purpose of the corporation.

6. To receive gifts and grants of money and property of every kind and administer and use same for the religious and charitable purpose for which the corporation is organized and to do anything necessary for the accomplishments of these purposes.

7. The purposes for which the corporation is organized are exclusively religious, charitable, scientific, literacy, and educational within the meaning of Section 501 (c) (3) of Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law. Said corporation is organized for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501 (c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue law. Notwithstanding any other provision of these articles, the organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income tax under Section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision.

This ministry was established to give 'hope' to God's people. We will minister to the needs of the community through:




- A Daycare Center- a childcare center for working parents.

**ARTICLE XII**

The Corporation reserves the right to amend, alter, change or repeal any provision contained in this Articles of Incorporation, in the manner now hereafter prescribed by the Statute, and all rights conferred upon members herein are granted subject to their reservations.

**ARTICLE XIII**

Directors of the Corporation shall not be liable to either the Corporation or its members for monetary damages for a breach of fiduciary duties unless the breach involves: (1) a director's duty of loyalty to the Corporation or its members; (2) acts or omissions not in good faith or which involves intention misconduct or a knowing violation of law; (3) a transaction from which the director derived an improper personal benefit.
