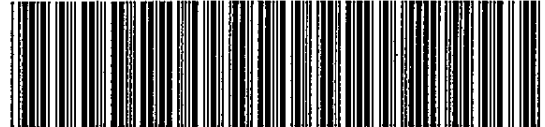

ARTICLES OF INCORPORATION

Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be Courage To Tell, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be

ARTICLE III PURPOSE

This corporation is organized for the purpose of providing a website and hotline for children experiencing sexual abuse. All phone calls, e-mails and chat rooms will be monitored or handled by volunteer licensed professionals trained in the area of child sexual abuse. The website and hotline will provide complete confidentiality and anonymity to all those who reach out for help.

This corporation will involve the participation of volunteers who will go out into the community to educate children about this confidential outlet for their pain and suffering with the hope to give the child the courage to tell and seek help. It will be implemented as a community service organization via the internet and over the telephone only for residents within the Miami-Dade County area possibly expanding into Broward County.

Notwithstanding any other provision of these Articles, this corporation shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501 © (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Revenue law.

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future Federal tax code.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed will be in accordance with the By-laws of the corporation.




