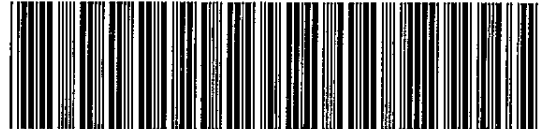

The undersigned, for the purpose of forming a not for profit corporation under Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation:

**ARTICLE I: NAME**

The name of the corporation is **RIAA, INC.**

**ARTICLE II: PRINCIPAL OFFICE**

The principal place of business and mailing address of the corporation is **7000 N. Federal Highway, 2<sup>nd</sup> Floor, Boca Raton, FL 33487.**

**ARTICLE III: PURPOSE**

**The specific nature of business of this non profit corporation is to operate an alumni association.**

**ARTICLE IV: QUALIFICATION**
