
Pursuant to section 617.1006, Florida Statutes, the undersigned Florida not for Profit Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The following adopted Amendment(s) is being added to Article Number Seven.

- a. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.

SECOND: There are no members, and the amendment was adopted by the board of directors on July 30, 2004. The number of votes cast for the amendment was sufficient for approval.
