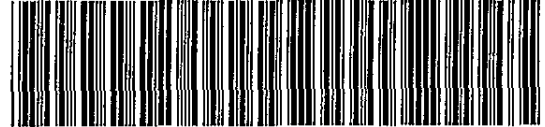



ARTICLES OF INCORPORATION

In Compliance with Chapter 617.F.S. (Not for Profit)

ARTICLE I - NAME

The name of the corporation shall be **FATHER DAMIEN SOCIETY, INC.**

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

Panama City, FL 32405

ARTICLE III - PURPOSE

The purpose for which the corporation is organized is to stop the progression of leprosy and minister to its residual effects. The purpose for which the corporation is organized is exclusively charitable within the meaning of Section 501(c)(3) of the Internal Revenue Code or the corresponding provisions of any future United States Internal Revenue Law. Notwithstanding any other provision of these Articles, this corporation shall not carry on any activities not permitted to be carried on by an organization exempted from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code or the corresponding provision of any future United States Internal Revenue Law.

ARTICLE IV - METHOD OF ELECTION OF DIRECTORS

Initially, the individuals listed in Article V below shall be the directors of the corporation until an election is held at the first annual meeting of the members. Subsequently, members of the Board of Directors of the corporation and the Officers of the corporation shall be elected in the manner set forth in the by-laws of the Father Damien Society, Inc.




