

**ARTICLES OF AMENDMENT
OF
BEACON PARK MASTER HOMEOWNERS ASSOCIATION, INC.**

Pursuant to the provisions of Chapter 713 of the Florida Statutes, we the undersigned directors hereby adopt the following Articles of Amendment to the Articles of Incorporation:

1. The name of the corporation is Beacon Park Phase 1 Master Homeowners Association, Inc.
2. The Articles of Incorporation are hereby amended as follows:
 - a. The provision on page 3 of the Articles entitled "Termination of Class B Membership" is deleted in its entirety and replaced with the following:

Termination of Class B Membership. The Class B Membership shall be terminated and become a Class A membership upon the earlier of the following: When the number of Class B votes equal the number of Class A votes; or on January 1, 2014.



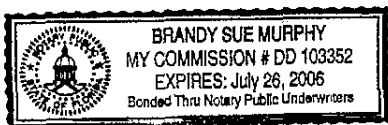
