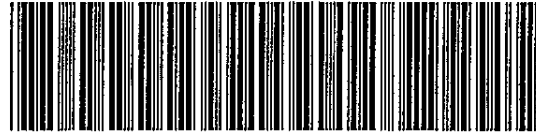



**ARTICLES OF AMENDMENT  
OF  
BEACON PARK PHASE 1 HOMEOWNERS ASSOCIATION, INC.**

Pursuant to the provisions of Chapter 713 of the Florida Statutes, we the undersigned directors hereby adopt the following Articles of Amendment to the Articles of Incorporation:

1. The name of the corporation is Beacon Park Phase 1 Homeowners Association, Inc.

2. The Articles of Incorporation are hereby amended as follows:

a. The provision on page 3 of the Articles entitled "Termination of Class B Membership" is deleted in its entirety and replaced with the following:

Termination of Class B Membership. The Class B Membership shall be terminated and become a Class A membership upon the earlier of the following: Declarants development of the property encumbered by the Declaration of Covenants, Conditions and Restrictions and sale of all of the lots therein; or on January 1, 2014.

This Amendment to the Articles of Incorporation for the corporation which is the subject of this amendment is a not for profit organization and this amendment was adopted on July 1, 2004 by the members and the number of votes was sufficient for approval.




