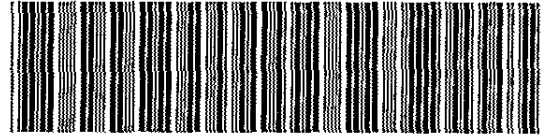

ARTICLES OF INCORPORATION

The undersigned being desirous of forming a corporation not for profit under the provisions of Chapter 720 of the Florida Statutes, and in accordance with all pertinent laws of the State of Florida, do hereby subscribe and adopt the following Articles of Incorporation for such corporation:

ARTICLE I

Name

The name of this corporation is : SeaScape at Amelia Homeowners Association, Inc. The initial principal address of the corporation is 829 Mary St., Fernandina Beach, Florida 32034.

ARTICLE II

Purpose

The general purpose of the business or businesses to be transacted by this corporation, together with and in addition to the authority and powers conferred by the laws of the State of Florida is to operate a homeowners association which will manage the common areas of SeaScape at Amelia Subdivision and will, in addition to its other duties, operate, maintain and manage the surface water or stormwater management system(s) in a manner consistent with the St. Johns River Water Management District

permit requirements and applicable District rules, and shall assist in the enforcement of the restrictions and covenants contained therein.

### ARTICLE III

#### Duration

The period of duration of this corporation is perpetual, unless dissolved according to law. Corporate existence shall commence upon the filing of these Articles of Incorporation with the Secretary of State of Florida.

### ARTICLE IV

#### Powers

This corporation shall have all powers provided for Corporations Not For Profit by Chapter 720 of the Florida Statutes or corresponding provisions of any subsequent statute, and all the powers of any other statute or law which do not in any way adversely affect the corporation's status as a corporation not for profit under Chapter 720 of the Florida Statutes.

### ARTICLE V

#### Registered Office and Registered Agent

The street address and city of the initial registered office of the corporation is 406 Ash Street, Fernandina Beach, Florida 32034, and the name of its initial registered agent at such address is A. Jeffrey Tomassetti.

ARTICLE VI

Directors

This corporation shall have three (3) directors initially. The number of directors may be increased or diminished from time to time as provided in the Bylaws but shall never be less than three (3). The directors shall be elected as provided in the Bylaws.

ARTICLE VII

Non Stock Basis

This corporation is organized upon a non-stock basis.

ARTICLE VIII

Incorporator

ARTICLE IX

Officers

There shall be a President, a Vice President, a Secretary, and a Treasurer, who will manage the affairs of the corporation, as well as such other officers as may be prescribed from time to time in the Bylaws. The officers shall be elected at the annual

meeting of the corporation and shall serve until their successors are elected and qualified. The officers shall serve such terms and perform such duties as may be prescribed from time to time in the Bylaws.

#### ARTICLE X

##### By-Laws

The Board of Directors of this corporation shall adopt Bylaws not inconsistent with these Articles of Incorporation for the conduct of the corporation's business and the carrying out of its purposes.

#### ARTICLE XI

##### Stormwater Assessments

The corporation shall levy and collect adequate assessments against members of the corporation for the costs of maintenance and operation of the surface water or stormwater management system. The assessments shall be used for the maintenance and repair of the surface water or stormwater management systems including but not limited to work within retention areas, drainage structures and drainage easements.

#### ARTICLE XII

##### Termination

In the event of termination, dissolution or final liquidation of the corporation, the responsibility for the operation and maintenance of the surface water or stormwater management system must be transferred to and accepted by an

entity which would comply with Section 40C-42.027, F.A.C., and be approved by the St. Johns River Water Management District prior to such termination, dissolution or liquidation.


ARTICLE XIII

Amendments to Articles of Incorporation

These Articles of Incorporation may be amended from time to time as provided by the laws of Florida applicable to corporations not for profit. In the event there shall be no specific provision, or adequate provisions, for such amendment under Florida law at the time of such intended amendment, then the manner of amendment shall be that manner of amendment provided under Florida Statutes 720, to the extent this Statute does not conflict with applicable law then in effect.

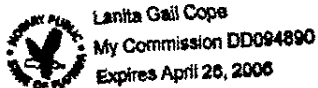


