ARTICLE I, NAME,

ARTICLE V. MANNER OF ELECTION.

The manner in which the directors are elected or appointed: Elections shall take place at the annual session of the subject corporation which date and place shall be chosen at the discretion of the Elected Officers of the Board of Directors, but said chosen date shall fall within 60 days prior to or after February 28th of each year. Directors shall serve for a period of 2 years and the Elected Officers shall be comprised of the President, Executive Director, Secretary, Treasurer, Public Relations Secretary, and Immediate Past President. Each of the elected officers shall have one vote. Appointed Officers of the Board of Directors shall consist of the chairs of the Special Committees. The Officer of each committee shall be appointed by the President with approval of the Elected Board of Directors. Appointed Officers have no right to vote in Board of Director affairs with the exception of the Regional Director who shall have one vote.
