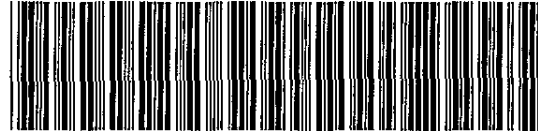

**BY-LAWS**

**ARTICLE I**  
**NAME**

The name of the corporation shall be Harvesttime Community Development Corporation.

**ARTICLE II**

**ARTICLE III**  
**PURPOSE**

The corporation is organized under the Florida Not-For Profit Corporation Act (FS Chapter 617) exclusively for charitable, educational, and scientific purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1986, as amended (the "Code"). It shall operate as a publicly supported, charitable, "community fund" as defined Treasury Regulations Section 1.170A-9 (c)(11). Income or principal may be distributed for such purposes to other publicly charitable corporations recognized by the Internal Revenue Service to be exempt from income taxation under Code Sections 501 (c)(3) and with respect to which donations are deductible under Code Sections 170 (c)(1) or 170 (c)(2)(B) and to projects and individuals as grant or scholarship as provided in the By-laws of the Corporation.

Our principal purpose is to serve as a community based organization; to provide a continuum of care to improve the quality of life of financially disadvantaged children, youth, and families without regard to race, sex, religion, creed, national or ethnic origin.

1. The establishment and operation of the programs to meet the moral, social, educational, health, consultants, bonds, and land development (construction of new homes as well as rehabilitation of existing homes), and charitable uplift of all citizen's needs in the State of Florida. However, we may expand wherever the need to serve human kind may exist.
