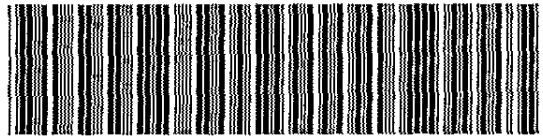

Articles of Incorporation

OF

The undersigned incorporators, a natural person 18 years of age or older, in order to form a corporate entity adopts the following articles of incorporation.

ARTICLE I

NAME

The name of the corporation shall be: **Advocacy Center for Customized Effective Support Solutions, Inc.**

ARTICLE II

EFFECTIVE DATE

The effective date of incorporation shall be April 27, 2004.

ARTICLE III

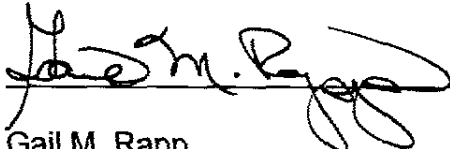

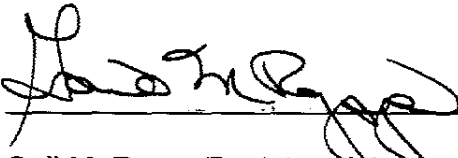
