# Triathlon Club Constitution

## Article I

# Club Purpose

<u>Gold Coast Triathletes</u> is an organized club dedicated to the educational pursuit of triathlon, general physical fitness, and the representation of the sport of triathlon within the community

# Article II

## Club Name

The official name shall be \_\_\_\_\_ Gold Coast Triathletes

# Article III

# Club Membership

Membership shall be open to any individual who shares in the common purpose of the Gold Coast Triathletes

Triathlon Club.

Membership shall be granted without discrimination upon basis of race, creed, color, religion, age, sex, national origin, and physical or mental handicap.

# Article IV

## Club Officers

Four officers and Five directors shall comprise the <u>Gold Coast Triathletes</u> Triathlon Club Executive Committee. Unless otherwise stated, terms commence on the 1<sup>st</sup> of April and run for two years. President Elect and Past President are short term positions to ensure continuity of the club, in an election year.

The officers are;

**President** – presides over meetings, conducts business for the club (but must have approval from the Executive Committee before entering into any legally binding matters), can appoint members to fill any board or officer vacancies that occur during the term, but the President shall not serve more than two consecutive terms.

**Vice President** – shall act as race director, event and guest speaker coordinator. In the absence of the President, the Vice President shall act on behalf of the President.

**Secretary** – is responsible for keeping accurate minutes at meetings and maintaining the record book of the minutes, Treasurer's reports and a current roster of the club's members.

**Treasurer** — collects club dues, pays club debts, and accounts for club finances with a monthly report to the Executive Committee.

**Directors** [5] - participate in officer's meetings and vote on club policies.

**President Elect** – immediately upon election to the office of President for the upcoming term, but prior to taking office as President of the Club, the President Elect shall become a member of the Executive Committee as a "trainee" but shall not have the right to vote on any matter prior to commencing their term of office as President of the Club.

Past President – shall be an Executive Committee member for a term of six (6) months commencing immediately upon the expiration of their term of office as President. The role of the Past President in the Executive Committee shall be that of an advisor to ensure continuity in the direction of the Club. Therefore, the Past President shall not have the right to vote on any matter in their capacity as Past President.

# Article V

#### **Executive Committee**

Executive Committee meetings shall be held on the <u>Introdav</u> of each month. Dates and times of the Executive Committee and agenda items are to be published in the clubs message board or web site, or newsletter. Special meetings may be called by the President or by seven current members who collectively petition the Executive Committee in writing, at least seven days before the intended special meeting. All Executive Committee meetings are open to the membership. The Executive Committee can appoint committees as needed for club business or activities. There must be five Executive Committee members present to have a quorum. Roberts Rules of Order will govern all Executive Committee meetings.

#### Article VI

## Club meetings

Club meetings shall be held on the \_\_3<sup>rd</sup> Thursday\_ of each month. Dates, times and location are to be published in the clubs message board, web site or newsletter.

#### Article VII

#### Club Elections

The President shall establish a nominating committee at the December Executive Committee meeting. The nominating committee shall consist of one Executive Committee member and one current club member at large. The committee shall ask for nominations from the floor of the October and November meetings. The committee shall prepare a slate of officers and directors for presentation at the December meeting and request final nominations from the membership. A slate of officers and directors will be presented to the membership at the January meeting for election by vote from the membership.

#### Article VIII

#### Amendments to the Constitution

Proposed amendments will be recommended by the Executive Committee, and shall be posted in the club newsletter fifteen (15) days before the next club meeting, and shall be voted on by the club membership at a regularly scheduled meeting.

#### Article IX

## Compliance

This constitution shall comply with the applicable Federal, State, County, and City laws and regulations.
