

**ARTICLES OF INCORPORATION**  
In Compliance with Chapter 617, F.S. (Not for Profit)  
**OF**  
**UNITED MISSIONARY BAPTIST CHURCH, INC.**

In compliance with the requirements of F.S. Chapter 607, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a Not for Profit corporation.

**ARTICLE I**

The name of the Corporation shall be: United Missionary Baptist Church, Inc.

**ARTICLE II**

The street address of the principal office of the Corporation is: 730 Bryant Village, Bryant, Palm Beach County, Florida 33439.

The mailing address of the Corporation is: Post Office Box 656, Pahokee, Palm Beach County, Florida 33476.

**ARTICLE III**

This corporation is organized for the purposes of the ministering and evangelical needs of mankind and shall have all powers consistent with and provided by Chapter 617 of the Florida Statutes regarding corporations not for profit.

**ARTICLE IV**

This corporation is organized as a non-profit organization and therefore under a non-stock basis.

**ARTICLE V**
