ARTICLE I: NAME

THE FOREGOING PURPOSES AND ACTIVITIES WILL BE INTERPRETED AS EXAMPLES ONLY AND NOT AS LIMITATIONS, AND NOTHING THEREIN SHALL BE DEEMED AS PROHIBITING THE CORPORATION FROM EXTENDING ITS ACTIVITIES TO ANY RELATED OR OTHERWISE PERMISSIBLE LAWFUL BUSINESS PURPOSES, WHICH MAY BECOME NECESSARY, OR DESIRABLE FOR THE FURTHERANCE OF THE CORPORATE OBJECTIVES EXPRESSED ABOVE.

ARTICLE IV: MANNER OF ELECTIONS

THERE WILL BE THREE DIRECTORS APPOINTED BY CONSENSUS OF EXISTING DIRECTORS. IN THE EVENT OF THE DEATH OR RESIGNATION OF THE SENIOR DIRECTOR THE EXECUTIVE DIRECTOR ASSUMES THAT POSITION AND APPOINTS A NEW DIRECTOR WITHOUT CONSENSUS OF THE JUNIOR DIRECTOR.
