Articles of Incorporation
Of
Radiant Living Worship Center
(Pursuant to Chapter 617.0202, F.S)

We the undersigned, all being of full age, and citizens of the United States, for the purposes of incorporating a church under Chapter 617, Florida Statutes (F.S.) do hereby file these articles for the purpose and purposes herein set forth as follows:

Article I

The name of the proposed incorporated church is to be RADIANT LIVING WORSHIP CENTER, INC.

Article II

The principal place of business will be:

Article III

The specific purpose or purposes for which the corporation is organized are as follows:

- a) For religious worship and conduct religious services in keeping with Evangelical and Pentecostal practices and traditions of Protestant Christianity.
- b) To foster, promote, and spread the teachings and preaching of the Holy Scriptures and the Gospels, and the belief in and of the Lord Jesus Christ as Man's Savior. The New Testament the only rule for Government and discipline.
- c) To advance, promote, publish, spread and propagate the principals and tenants of the Christian Faith: to establish maintain and advance its doctrines and disciplines; to determine and establish rules and regulations in this local church.

- g) To acquire, maintain, take and hold by conveyance, bequest, gift, or devise, real and personal property for the purposes of the corporation; and to purchase, lease, and erect buildings therefore; to take and hold grants, donations, bequests and devisee of real and personal property, jointly and in trust and apply the same, or
