## Articles of Incorporation In Compliance with Chapter 617, F.S. (Not for Profit)

Articles of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

#### ARTICLE I NAME
