ARTICLES OF RESTATEMENT OF THE

ARTICLES OF INCORPORATION OF THE EPISCOPAL CURSILLO IN SOUTHEAST FLORIDA, INC.

The Articles of Incorporation of the above corporation are hereby amended and restated, in their entirety, as set forth below.

<u>ARTICLE I - NAME</u>: From this date forward, the name of the corporation shall be The Episcopal Cursillo Movement in the Diocese of Southeast Florida, Inc.

ARTICLE II – PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS. The principal place of business and the mailing address of this Corporation shall be: 8895 North Military Trail 205C, Palm Beach Gardens, Fl 33410.

ARTICLE III — MISSION AND PURPOSE. The mission and purpose of this Corporation shall be to support, encourage and effect the spreading of the Gospel of Jesus Christ throughout the world by actively pursuing the goals and programs of the Cursillo Movement as the Cursillo Movement is developed and implemented in The Episcopal Church in the Diocese of Southeast Florida. The Corporation shall be a member of and belong to the Episcopal Church and to the Diocese, and shall be subordinate and subject to the constitution, canons and doctrines of The Episcopal Church and to the constitution and canons of the Diocese.

<u>ARTICLE IV – MEMBERSHIP</u>. The Corporation shall have no members.

ARTICLE V - INITIAL REGISTERED AGENT AND STREET ADDRESS. The Registered Office of the Corporation shall be located at 8850 North Military Trail 205C, Palm Beach Gardens, Florida 33410. The Registered Agent shall be The Rev. Mary Gray-Reeves, Archdeacon for Deployment, 8895 North Military Tail 205C, Palm Beach Gardens, Florida 334410.

ARTICLE VI – OFFICERS AND DIRECTORS. The corporation shall have such officers and directors as shall be determined under the Bylaws of the Corporation as adopted and amended from time to time by the Board of Directors, provided, however, that any such officers or directors not directly appointed by the Bishop Diocesan of the Diocese of Southeast Florida shall be subject to the approval of the Bishop and shall serve at his pleasure. The Board of Directors of the Corporation may also be referred to as "The Secretariat".

ARTICLE VIII - BYLAWS. The Bylaws of this Corporation shall be adopted and amended from time to time by majority vote of the Board of Directors, and shall not be inconsistent with these Articles of Incorporation.

ARTICLE IX - AMENDMENT. These Articles of Incorporation may be amended by majority vote of the Board of Directors; provided, however, that no amendment to the Articles of Incorporation shall be valid or effective until this Corporation has secured the consent of the Bishop, the Executive Board, and the Standing Committee of The Diocese of Southeast Florida, as provided in Diocesan Canon XX, Section 6.

<u>ARTICLE X - TRANSACTIONS RELATING TO REAL PROPERTY.</u> This Corporation shall not encumber, sell, alienate, transfer or convey real property except as provided by the canons of the Diocese.

ARTICLE XI – ACTIVITIES NOT PERMITTED. Notwithstanding any other provision of these Articles, the Corporation will not engage in any activities not permitted by (a) a corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law ("the Code") or (b) a corporation, contributions to which are deductible under Section 170(c)(2) of the Code.

ARTICLE XII - DISSOLUTION. In the case of the dissolution of the Corporation, all of its residual assets shall be distributed to the Diocese of Southeast Florida or, if it is not then an organization described in each of sections 501(c)(3) and 170(c) of the Code, to the Episcopal Church or, if it is not then such an organization, to an organization which is so described as shall be designated by the last Board of Directors of this Corporation.

Members of the corporation are not entitled to vote on proposed amendments to the Articles of Incorporation. The required approvals by the Bishop, Executive Board and Standing Committee of the Diocese of Southeast Florida appear at the end of this document.
