

ARTICLE I NAME

The name of this corporation shall be: The Florida Association of Security Officers, Agencies and Associates, Inc. The corporation's registered office is located at 560 Lilac Road, Casselberry, Florida 32707.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The purpose for which the corporation is organized is: To elevate and advance the quality of service and public perception of the private security industry by promoting industry growth, and providing information, education, improved principles, legislative and regulatory agency advocacy, moneysaving benefits, and personal development.
