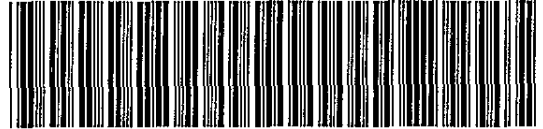

#### **ARTICLE I NAME**
