PREAMBLE

The Partnership for American Veterans, Inc. is an IRS 501C3 Non-profit Organization dedicated to the cause of serving, supporting, educating and assisting all Honorably Discharged US Military Veterans and their families, by way of Volunteerism, raising necessary finances to meet their needs, directly and indirectly through donations for the Voluntary Services of the VA Medical Facilities (Veterans Affairs Voluntary Services (VAVS) Programs) of the following nine (9) Florida Counties: Pinellas, Manatee, Hendry, Sarasota, Desoto, Highlands, Charlotte, Lee, and Collier. We are an independent Volunteer Organization and are not a part of the Department of Veterans Affairs.

ARTICLES OF INCORPORATION

ARTICLE I: Name

The name of this Corporation shall be the Partnership For American Veterans, Inc. which was Incorporated with Articles Of Incorporation filed at the Secretary Of State of Florida, and in full compliance with the State of Florida and IRS Laws and Regulations.

ARTICLE II: Principle Place Of Business

The Principle place of business will be P.O. Box 629, Bay Pines, Florida 33744

ARTICLE III: Purposes or Mission

2.1 The purposes or mission of this Corporation is to serve the Honorably Discharged Veterans of the US Military and their families, who may be Outpatients or Inpatients enrolled in the VA Medical and (or) Compensation/Benefits Programs in the above mentioned Target Counties in the Preamble.

- 2.2 To cooperate with all duly organized Veterans and Community Organizations for the Purposes and Mission of Partnership for American Veterans, Inc.**
- 2.3 To expedite and assist in the well-being and rehabilitation, and education of these Veterans by Volunteerism, serving and supporting the established Volunteer Services Programs.**
- 2.4 To act as a Liaison and/or Resource Agent between the Veteran and the VA.**
- 2.5 To be the repository and dispenser for all Fund Raising Activities and proceeds received from Individual, Business and/or Corporate resources to support the established Programs of the Veterans Affairs Voluntary Services (VAVS).**

ARTICLE IV: Election Of Directors and Officers

- 4.1 The Directors of the Corporation shall be those individuals who are in good standing and duly Certified Organizational Representatives or Deputies of the Veterans and Community Service Organizations in the target service area listed in the Preamble.**
- 4.2 The Directors shall be appointed for a term of two (2) years. However, they shall be permitted to succeed themselves, if duly appointed.**
- 4.3 There shall be a President, Vice President, Secretary, and Treasurer and three (3) Directors at large.**
- 4.4 Other Officers or Committees shall be appointed to further carry out the Purposes or Mission of the Corporation.**
