

## ARTICLES OF INCORPORATION OF IGLESIA MISIONERA CORDERO DE DIOS

(In compliance with Chapter 617, F.S., (Not for Profit)

## ARTICLE I (NAME)

The name of the corporation shall be: Iglesia Misionera Cordero de Dios, Inc.
