ARTICLES OF INCORPORATION

C1

SOCIETY FOR THE ADVANCEMENT OF SCIENCE.

The authorizes, is willing as a Incorporated not for Profit Corporation under the President of the Republic of Malta to adopt the following Articles of Incorporation:

1.1 The name of this corporation is "Society for the Advancement of Science" ("Corporation")

1.2 The mailing address and principal place of business of the Corporation is 2415 Worcester Street, Suite 100, Cambridge, MA 02133.

1.3 The period of incorporation is perpetual, unless sooner dissolved.

1.4 The date and time of incorporation of the Corporation is set forth below:

1.5 The general purpose of the Corporation is to engage in the propagation of knowledge through the publication of scientific and technical papers and the organization of scientific meetings and other activities. All purposes set forth in the Corporation's articles of incorporation are set forth in Section 301(2)(B) of the Internal Revenue Code of 1986 as amended (the "Code").

1.6 The mailing address of the initial filing office of the Corporation is #421 Worcester Street, Cambridge, MA 02133; no other mailing address shall be registered except the same address as indicated above.

1.7 A. No one of the members bearing the name of the Corporation shall have individual control over the affairs of the Corporation, but shall have the power to make decisions, except that the Corporation shall not transact business or empower itself to do so, except by resolution of the members.

B. Notwithstanding the above, any member may exercise authority to bind the Corporation in his or her name, and the Corporation shall not be liable for any obligations contracted by such member, provided that the member has authority to do so.

C. Notwithstanding any other provision of these Articles of Incorporation, the Corporation shall have authority to carry on business at any place in the United States or elsewhere, and the Corporation shall not be liable for any debts or expenses incurred in the course of business, except to the extent provided in Section 301(3)(B) of the Code or (1)(b) of the Corporation's articles of incorporation.

IX. The ultimate object of this Co-operation, is to assist and promote
the growth and development of the agricultural and industrial
institutions of the Co-operative Societies throughout the country.
The Co-operative Societies will be entitled to receive from the
Government of India, such financial assistance as may be
necessary for the promotion of their objects.

The first General Meeting consisting of the Directors, who shall be called by the Chairman of the Committee, shall be held at the place of meeting of the Committee.
