

# PLAN OF MERGER OF PHILLIPPI LANDINGS BOAT ASSOCIATION, INC., WITH AND INTO PHILLIPPI LANDINGS COMMUNITY ASSOCIATION, INC.

Phillippi Landings Boat Association, Inc., a Florida not-for-profit corporation, and Phillippi Landings Community Association, Inc., a Florida not-for-profit corporation, hereby adopt and approve the following plan as the Plan of Merger required by Section 617.1101, Florida Statutes. The terms of the plan are as follows:

- 1. Names. The names of the business entitles planning to merge are Phillippi Landings Boat Association, Inc., a Florida not-for-profit corporation (the "Boat Association"), and Phillippi Landings Community Association, Inc., a Florida not-for-profit corporation (the "Community Association"). As a result of the merger, Boat Association shall be merged with and Into Community Association. Community Association shall be the surviving business entity.
- 2. <u>Effective Date</u>. The merger shall be effective on December 31, 2013 (the "Effective Date").
- 3. The Merger. Subject to the terms and conditions of this Plan and in accordance with the applicable provisions of the Florida Not For Profit Corporation Act (the "Act"), at the Effective Date, Boat Association shall be merged with and into Community Association. As a result of the Merger, the separate corporate existence of Boat Association shall cease, and Community Association shall continue (a) as the surviving corporation (the "Surviving Corporation") and (b) to be governed by the Act.
- 4. <u>Name of Surviving Corporation</u>. The name of the Surviving Corporation as of the Effective Date will be "Phillippi Landings Community Association, Inc."
- 5. Articles of Incorporation. Commencing as of the Effective Date, the Articles of Incorporation and Bylaws of Community Association shall be the articles of incorporation and bylaws of the Surviving Corporation, except as such articles of incorporation and bylaws may be amended from time to time.
