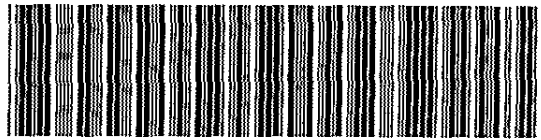

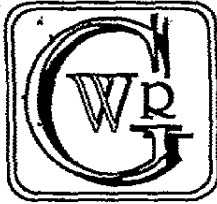

Enclosed is a check in the amount of \$43.75. This is for the amendment filing fee of \$35.00 and for a certified copy.

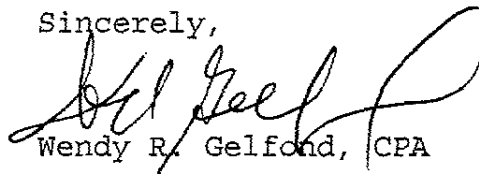

ARTICLE I NAME

The name of the corporation shall be: TZIRUF DORE INC.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

Said corporation is organized exclusively for charitable, religious, and educational purposes under Section 501(c)(3) of the Internal Revenue Code.

Upon dissolution of this corporation assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.
