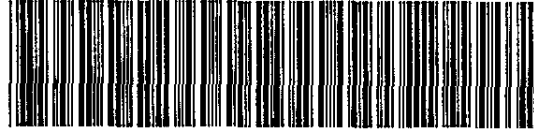

ARTICLES OF INCORPORATION  
OF  
UNITED HUMANITARIANS PROMOTING ANIMAL WELFARE, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I  
NAME

The name of the corporation shall be: **UNITED HUMANITARIANS PROMOTING ANIMAL WELFARE, INC.**

ARTICLE II  
PRINCIPAL OFFICE

ARTICLE III  
PURPOSES

The general purposes for which the corporation is organized are the following:

- a. fundraising for animal welfare;
- b. any and all purposes permitted by Chapter 617, Florida Statutes, and other applicable law; and
- c. to accomplish the foregoing purposes, the corporation shall have all corporate powers permitted under Florida law, including the power to borrow monies.

The Corporation shall indemnify each Officer and Director, including former Officers and Directors, to the full extent permitted by law.


