#### ARTICLE 1

The name of the corporation is: Iglesia Cristiana Vida Nueva de Bradenton, Inc.

#### **ARTICLE II**

The term of the existence of the corporation is perpetual.

#### **ARTICLE III**

The purpose for which the corporation is formed is to establish and maintain a religious society to conduct services designed to reach people for Christ, and that we preserve our God-given heritage, the faith once delivered to the saints especially the doctrine and experience of sanctification as a work of the grace of God and also that we may cooperate effectually with other branches of the Church of Jesus Christ in advancing God's kingdom among men.

For the accomplishment of these objectives the corporation shall have the power to distribute books, magazines, papers and other literatures that will further carry out the objectives of this corporation; to acquire by purchase or gifts such real and personal property as may be necessary to carry out the objectives of this corporation and to recieve subscriptions and donations of real and personal property to be applied to the uses and purposes of the corporation; to mortgage and otherwise encumber any of its property or to sell and convey the same; and to permit the use of its property for religious, educational, benevolent or other lawful purposes.

- (b) Following such orientation the prospective members shall be considered for membership by the Board of Directors of the corporation.
