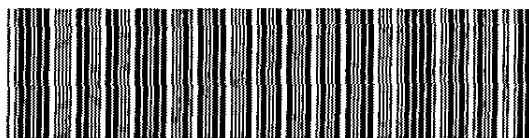

OF

The undersigned incorporator, for the purpose of forming a corporation under Florida Not For Profit Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I
