The undersigned, acting as incorporator(s) of a corporation to chapter 617, Florida Staffles, adopt(s) the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation shall be: LORAINE ELIZABETH FOUNDATION, INC.

The principal business and the mailing address of this corporation shall be:

19127 W. Lake Drive, Miami Lakes, Florida 33015

ARTICLE II - NOT FOR PROFIT

The Corporation is a nonprofit corporation under the laws of the State of Florida. The Corporation is not formed for pecuniary profit. No part of the income or assets of the Corporation is distributable to or for the benefit of its Members, Trustees or Officers, except to the extent permissible under law. The Corporation is entitled to receive charitable contributions and to disburse said contributions in accordance with the laws of the State of Florida.

ARTICLE III - DURATION

The duration (term) of the Corporation is perpetual.

ARTICLE IV - PURPOSE(S)

The specific purpose(s) for which the corporation is organized is (are). To provide assistance to individuals of low income and orientation in how to provide for their basic needs including food, obtaining legal services not available to the poor, education and medical services as well as transportation.

The organization is organized exclusively for charitable, religious, and/or scientific purposes under section 501(c)(3) of the Internal Revenue Code.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the

publishing of distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code or corresponding section of any future federal tax code.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

ARTICLE V - MEMBERSHIP

MEMBERSHIP IN CORPORATION: Membership in the corporation shall be open to persons of good moral character, with a desire to assist the poor in our community and to orient those individuals of low income in obtaining vital services such as food, medical and legal services.

ARTICLE VI - INITIAL DIRECTORS
