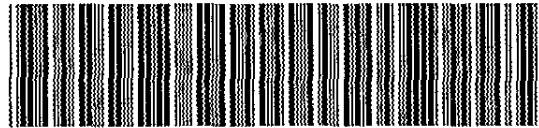



**ARTICLES OF INCORPORATION OF
AND THE WOMEN GATHER, INC.
(A FLORIDA NOT-FOR-PROFIT CORPORATION)**

ARTICLE I: NAME

The name of the corporation shall be"


