Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

FIRST: Amendments adopted:

Article I: Name (Amend name)

The Name of this Corporation (hereinafter referred to as the "Organization") is Adopt A Nursing Home and Assisted Living Facilities, Inc.

Article II: Principal Office (Add new mailing address)
