The name of the corporation shall be: Grand Ridge Baptist Church, Inc.

ARTICLE II PRINCIPLE OFFICE

The principal place of business of this corporation shall be: 2093 Porter Avenue, Grand Ridge, Florida 32442. The principal mailing address of this corporation shall be: Post Office Box 380, Grand Ridge, Florida 32442.
