

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF ILED 1201 WEST CONDOMINIUM ASSOCIATION, INC.

A Florida corporation not for profit

THESE ARTICLES OF AMENDMENT to Articles of Incorporation of 1201 West Control in STATE Association, Inc. Are made this 27th day of July, 2004 pursuant to a meeting of all incubers of the Corporation, called on an emergency basis, and the Articles of Incorporation of the Corporation are URIDA hereby amended as follows:

1. Article X is amended to provide, in its entirety:

ARTICLE X - DISSOLUTION

The Association may be dissolved, only after the dissolution of the Condominium in accordance with Florida Statutes, Chapter 718, with the assent given in writing and signed by not less than seventyfive percent (75%) of the voting members. Upon dissolution of the Association, other than incident to a merger or consolidation, the assets of the Association shall be dedicated to an appropriate public agency to be used for purposes similar to those for which the Association was created.

- 2. In each and every other manner and respect, the Articles shall remain as originally filed.
- 3. This Amendment, executed by the President, was approved by all members of the Association at an emergency meeting called for the sole purpose of amending the Articles as set forth herein.
- 4. This Amendment shall be effective upon the earlier of its execution by an appropriate officer of the Corporation or the date it is filed with the Secretary of State of the State of Florida.
