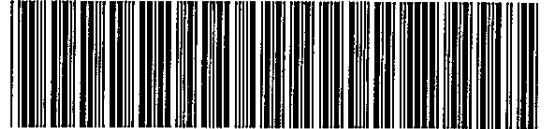

**ARTICLES OF INCORPORATION  
FOR

*The undersigned, acting as incorporators of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:*

- I. **CORPORATION NAME** - The name of the Corporation shall be **AFRICAN AMERICAN EDUCATIONAL AND CULTURAL CENTER, INC.**
- II. **PRINCIPAL OFFICE** - **AFRICAN AMERICAN EDUCATIONAL AND CULTURAL CENTER, INC.** shall have its principal office(s) at 1250 Holt Avenue, Clearwater, Pinellas County, Florida.
- III. **PURPOSE** - The specific purposes for which **AFRICAN AMERICAN EDUCATIONAL AND CULTURAL CENTER, INC.** is organized are exclusively charitable, educational, cultural, scientific, literary and faith-based within the meaning of section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law. The **AFRICAN AMERICAN EDUCATIONAL AND CULTURAL CENTER, INC.** will provide and/or partner with others to provide parenting education, family literacy services, economic development activities, child/youth development activities, linkage to health care, community outreach and space usage for meetings/activities.
- IV. **MANNER OF ELECTION OF DIRECTOR(S)/TRUSTEE(S)** - The Director(s)/Trustee(s) shall be elected or appointed as provided in the bylaws of the Corporation.
- V. **LIMITATION OF CORPORATE POWERS** - Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.




