

- ONE: The name and address of this principal corporation is ALL Inclusive, Inc. Located at 3414 North Orange Blossom Trail, Orlando, Florida 32804. The corporation is organized pursuant to the **FLORIDA** non-profit Corporation Code.
- TWO: This corporation is a nonprofit Public Benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for charitable and educational purposes to aid the poor and disadvantaged individuals and families towards a life of self-sufficiency. The programs will consist of, but shall not be limited to: Drama, Dance, Community Speak, the Arts, Disadvantaged Individuals and Families, Job Training, Job Placement, Land Acquisition, Housing, Employment, Literacy, Counseling, Substance Abuse Awareness and Prevention, Tutoring, and other programs to aid those in need.
- THREE: The duration of this corporation shall be perpetual, no stock and shall have no members.


