

FIRST AMENDMENT TO AMENDED AND RESTATED ARTICLES OF INCORPORATION OF PORT ORANGE PLANTATION HOMEOWNERS ASSOCIATION, INC.

WHEREAS, the Association has executed and recorded its duly adopted Amended and Restated Articles of Incorporation of Port Orange Plantation Homeowners Association, Inc. ("Articles of Incorporation") in Official Records Book 5855, Page 3833 of the Official Records of Volusia County, Florida; and

WHEREAS, the Articles of Incorporation provide in Article XIII(B) that, after the "First Conveyance" (as defined in Article V(A) of the Articles of Incorporation) and prior to the "Turnover Date" (as defined in Article V(D)(2) of the Articles of Incorporation), the Articles of Incorporation may be amended by written consent of the majority of the members of the Board of Directors of the Association at a duly called meeting of the Board of Directors; and

WHEREAS, the Articles of Incorporation, in Article XIII(D), prohibit any amendment that would prejudice the rights of any "Institutional Mortgagee" (as defined in the Amended and Restated Declaration and General Protective Covenants for Port Orange Plantation ("Declaration"); and

WHEREAS, the Articles of Incorporation, in Article XIII(F), prohibit any amendment that would abridge, prejudice, amend or alter the rights of D.R. Horton, Inc.-Jacksonville ("Declarant") without the prior written consent of Declarant; and

WHEREAS, the Articles of Incorporation, in Article XIII(F), prohibit any amendment without the prior written consent of Declarant, so long as Declarant holds either a leasehold interest in or title to at least one (1) "Lot" (as defined in the Articles of Incorporation); and

WHEREAS, as of the date of this First Amendment, First Conveyance has occurred; and

WHEREAS, as of the date of this First Amendment, the Turnover Date has not occurred; and

WHEREAS, the rights of any Institutional Mortgagee shall not be affected by this First Amendment; and

WHEREAS, Declarant has provided its prior written consent to this First Amendment; and

NOW, THEREFORE, the Association hereby declares that the Articles of Incorporation are hereby amended as follows:

- I. ARTICLE V MEMBERS AND VOTING, PARAGRAPH I is repealed in its entirety and replaced with the following:
- I. A quorum for the purpose of election of not less than the majority of the Board on the Turnover Date (as specified in Article V(D)), shall consist of persons entitled to cast at least ten percent (10%) of the total number of votes of the Members. For all other purposes, unless some greater number is provided for in the Port Orange Plantation Documents, a quorum shall consist of persons entitled to cast at least twenty percent (20%) of the total number of votes of the Members.
- 2. This First Amendment shall become effective upon recording amongst the Public Records of Volusia County, Florida.
- 3. Except as modified by this First Amendment, the Articles of Incorporation shall remain in full force and effect in accordance with the terms thereof.
