### ARTICLES OF INCORPORATION

# OF ABC OF TAMPA, INC.

The undersigned incorporator hereby forms a corporation under Chapter 617 (Not for Profit) of the laws of the State of Florida.

#### ARTICLE I. NAME

The name of the corporation shall be:

### ABC OF TAMPA, INC.

#### ARTICLE II PRINCIPAL OFFICE

The address of the principal office of this corporation shall be 16608 Norwood Drive. Tampa, Florida 33624, and the mailing address of the corporation shall be the same.

#### ARTICLE III. PURPOSE
