The undersigned, for the purpose of forming a corporation under the FLORIDA BUSINESS CORPORATION ACT, in compliance with Chapter 617, F.S., (Not for Profit), does hereby adopt the following Articles of Incorporation:

**ARTICLE I**

The name of this corporation shall be **WIDOWS SONS MASONIC MOTORCYCLE RIDERS ASSOCIATION-SOUTHERN JURISDICTION, INC.**

**ARTICLE II**

The street address of the principal office of the corporation is 5246 Blackjack Circle, Punta Gorda, Florida 33982.

**ARTICLE III**

The general nature of the business or businesses to be transacted by this corporation shall be: to provide Masonic education and comradery.

To conduct its affairs, carry on its operations, and have offices and exercise the powers granted to corporations under the Florida Statutes both within and without this State.

To elect or appoint officers and agents of the corporation and define their duties and fix

To make and alter bylaws, not inconsistent with these Articles of Incorporation or with the Florida Statutes, for the administration and regulation of the affairs of the corporation.

To make donations for the public welfare or for charitable, scientific or educational purposes.

To pay pensions and establish pension plans and other incentive plans for any or all of the directors, officers and employees of the corporation, and for any or all of the directors, officers and employees of any subsidiary of the corporation.

#### ARTICLE IV

The corporation will be subject to the authority of any national association, lodge, order, beneficial association, fraternal or beneficial society, foundation, federation, or other corporation, society, organization, or association not for profit.”

#### ARTICLE V

The method of election of the directors will be stated in the bylaws.

#### ARTICLE VI
