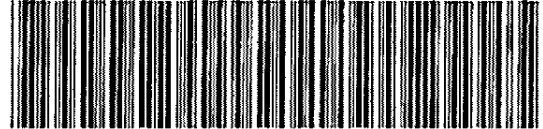

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

The purpose of PDM is to help people in the rural areas of developing countries to enable them to help themselves in such a way that our assistance will offer sustainable solutions to problems such as shortages of drinking water, main road improvement, living environment improvement, education, infectious disease control, sanitation and poverty.

We will focus on providing permanent solutions to villages where people trek several miles to collect drinking water in the heat of the sun and where people have lost their vision to treatable to treatable diseases caused by contaminated water. Our approach is in three parts:

1. By drilling new wells to pump clean drinkable water.
2. By training the local people on how to operate the well system so that it can be maintained.
3. By purification of existing water sources.

We will offer help in main road improvement in areas where transportation is difficult because of bad road conditions created by storm water and subsurface drainage problems.

In developing countries, sanitation is a serious problem and quite often refuse or trash is left scattered openly on roadways and children can be seen scavenging for food on these refuse dumps. Sometimes syringes and needles are left on beaches creating a potential health hazard. We will help the local population recycle and dispose their waste in a manner that the people and the environment can co-exist.

We will provide valuable recommendations and books to support basic education. We will provide public education to the local population in terms of preventive measures to
