Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

**FIRST:** Article III of the Articles of Incorporation which currently reads as follows:

Article III: The purpose of this non profit corporation is to provide a place of worship, as well as provide religious, charitable, scientific, literary and educational service, for its members.

shall be amended so as to change Article III thereof, and substitute the following provision in its place:

Article III: The purpose of this non profit corporation is to exclusively provide religious, charitable, and educational activities for its members as described under section 501(c)(3) of the Internal Revenue Code.

**SECOND:** The date of the adoption of the amendment was December 1, 2005.

**THIRD:** There are no members entitled to vote on the amendment. The amendment was adopted by the board of directors.
