ARTICLES OF INCORPORATION

OF

GOD WITH US, House of Worship for all Nations, INC.

ARTICLE I

The name of the Corporation shall be:

GOD WITH US, House of Worship for all Nations, INC.

ARTICLE II

The principal place of business and mailing address of the Corporation:

17010 NW 66 Court, Miami, Florida 33015

ARTICLE III

3.1 The Corporation is organized exclusively for religious, charitable and educational purposes. Further, the general purposes for which this Corporation is formed are to operate exclusively for such religious, charitable, and educational purposes as will qualify it as a Not-for-Profit organization under Chapter 617 of the Florida Statutes, or any corresponding section of the Statute; and, if so qualified, to also operate exclusively for such religious, educational and charitable purposes as will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1986. Some of these general purposes, without limitation, are teaching and educating pursuant to our faith as follows:

THE BIBLE

The sole basis of our authority is the Bible, composed of the sixty-six books of the Old and New Testaments. We believe that the Bible is the Word of God, fully inspired and without error, written under the inspiration of the Holy Spirit. Verbal inspiration refers to every word being God's, and plenary inspiration means that all of Scripture is equally inspired. Scripture, therefore, speaks with the full authority of God while reflecting the backgrounds, styles, and vocabularies of the human authors. We hold the Scriptures to be infallible and inerrant. They have full and final supreme authority on all matters of faith and conduct, and there are no other writings similarly inspired by God.

GOD

We believe that there is one true God, who is holy, eternal, all powerful, present everywhere, all knowing and sovereign. God is eternally existing in three persons -- Father, Son, and Holy Spirit. Each Person of the trinity is equal and each has a distinct ministry in relation to God's creation and purpose.

JESUS CHRIST

Jesus Christ is God the Son who chose to leave heaven according to God 's plan to redeem all of mankind. He become a man by being born through miraculous conception of the Holy Spirit and a virgin birth. He lived a life of perfect obedience to God the Father and voluntarily payed for the sins of all by dying on the cross as their substitute. He rose from the dead after 3 days, ascended into heaven after appearing to his disciples for 40 days and having been seen by over 500 people in his resurrected state. He sat down at the right hand of the Father, where He, the only Mediator between God and man, continually makes intercession for His own. He will one day return to the earth personally and visibly, to take the saints to Heaven for eternity.

HOLY SPIRIT

We believe that God the Holy Spirit is eternal and equally a divine person with all the attributes of God that can be found in the persons of God the Father and God the Son. The equal divinity of the person of God the Holy Spirit with the persons of God the Father and God the Son completes the supernatural reality of one God who is perfectly united in three divine persons that make up the trinity.

After the resurrection and ascension of Jesus Christ to heaven, God the Holy Spirit was sent into the world by God the Father and God the Son to convict men of sin, of judgment, and of righteousness. He is the agent of New Birth in Christ and at the point of salvation, permanently indwells every believer to become the source of assurance, strength, and wisdom. The Holy Spirit guides believers in understanding and applying Scripture. His power and control are appropriated by faith, making it possible for the believer to lead a life of Christ like character and to bear fruit to the glory of God the Father and God the Son.

Each church is independent and autonomous but we believe that the Church as the living spiritual body of Jesus Christ is composed of many members across the world who are united by the fact that they are true born again disciples of Jesus Christ, regardless of denominational or non-denominational affiliation.

WORSHIP OF GOD

God is the only one all born again believers in Jesus Christ should worship, to the exclusion of people, things, places, work, titles, creation or created angelic beings(to name a few). Worship encompasses thought, feeling and deed; it especially includes praise and thanksgiving which may be expressed publicly and privately and should be yielded to the direction of the Holy Spirit and not the natural man.

We believe that man was created in innocence under the law of his Maker, but voluntarily fell from his sinless and happy state. Consequently, all mankind are now sinners by nature and sin by choice and are therefore, without defense or excuse before a Holy God.

SALVATION

Because each individual man or woman is inherently 100% sinner he/she cannot save himself by any amount of good works or any religious system. The Good News is that God in his infinite love provided the only solution to every person's sin problem which keeps him or her separated from God. The solution is found in the person of God the Son, Jesus Christ, who became a man and lived among us without sin, willingly died on the cross to pay the penalty for all our pass, present and future sins and who rose from the dead to give each person who believes resurrection power over death and sin.

We believe that salvation is the free gift of God by grace, neither merited nor secured in part, or in whole, by any virtue or work of man. It is received only by personal faith in the Lord Jesus Christ. When God has begun a saving work in the heart of any person, He gives assurance in His Word that He will continue performing it until the day of its completion. Therefore those who are truly born again believers in Jesus Christ are eternally secure.

- 3.2 Notwithstanding any other provision of these Articles of Incorporation:
- (a) The Corporation shall not be operated for profit. It may only engage in activities that may be carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code and by a corporation to which contributions are deductible under Sections 170(c), 2055, and 2522 of the Internal Revenue Code. To the extent consistent with Section 501(c)(3), the Corporation may exercise any and all powers conferred upon non-profit Corporations by Chapter 617 of the Florida Statutes.
- (b) No part of the net earnings of the Corporation shall inure to the benefit of any Trustee or officer of the Corporation or any person having a personal or private interest in the activities of the Corporation. The Corporation may pay reasonable compensation for services rendered and may make payments or distributions in furtherance of the purposes set forth in Article III.
- (c) No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall be empowered to make the election authorized under the federal tax code. The Corporation shall not engage in the distribution of statements for any political campaign on behalf of or in opposition to any candidate for public office.

- 3.3 The Corporation is organized pursuant to Chapter 617 of the Florida Statutes and does not contemplate pecuniary gain or profit; it has no capital stock and is not authorized to issue capital stock.
- 3.4 In accordance with section 617.0834 of the Florida Statutes, no loans shall be made by the Corporation to its Trustees or officers.
 - 3.5 The term of the Corporation shall be perpetual.

ARTICLE IV

- 4.1 The manner in which Trustees for the Corporations Board of Trustees are elected or appointed shall be set forth in the bylaws of the Corporation.
- 4.2 All voting power, including, without limitation, power to vote on amending the Articles of Incorporation, is vested in the Board of Trustees of the Corporation. The number of Trustees constituting the initial Board of Trustees is three. The names and addresses of those people who are to serve as the initial Trustees are:

- 4.3 The internal affairs of the Corporation shall be regulated by the Board of Trustees according to the Corporations bylaws. The power to make, alter, amend or repeal the bylaws shall be vested in the Board of Trustees.
- 4.4 The manner of termination of membership in the Corporation shall be set forth in the bylaws of the Corporation.
