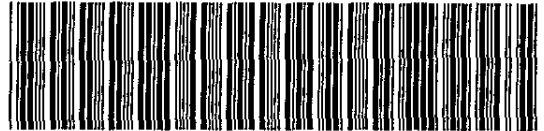

We the undersigned subscribers to those Articles of Incorporation. Each a natural person Competent to contract hereby associate ourselves together to from a corporation under the laws of the state of Florida.

**ARTICLE 1-NAME**

The name of this corporation shall be known as **Centro De Avivamiento Cristiano Ministerio Internacional, Inc.** This corporation shall not join, belong, or pay dues to any other corporation. However, member may do so if they desire to.
