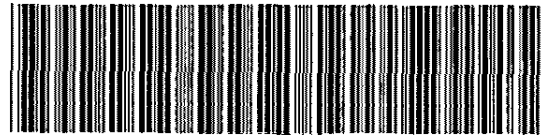

**ARTICLES OF INCORPORATION
OF
BLUEWATER BARRACUDA SWIM TEAM, INC.**

The undersigned, for the purpose of forming a Corporation under the Florida Corporation Act, do hereby adopt the following Articles of Incorporation and shall be a not for profit Corporation.

ARTICLE I - NAME

The name of the Corporation shall be **BLUEWATER BARRACUDA SWIM TEAM, INC.** PO Box 36, 303 Valparaiso, FL 32580.

ARTICLE II - DURATION

The duration of the corporation is for an indefinite period of time (i.e. perpetual)

ARTICLE IV - GENERAL PURPOSE

This Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding sections of any future code.

ARTICLE V - SPECIFIC PURPOSE

The Corporation intends to provide training opportunities and sanctioned competitions for the benefit of amateur athletes involved in the sport of swimming.

ARTICLE VI - RESTRICTIONS

No part of the net earnings of the Corporation shall inure to the benefit of, or distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on: (a) by a corporation exempt from Federal Income Tax under Section 170(c)(2) of the Internal Revenue Code (or the corresponding provision of any future United States Internal Revenue Law) or: (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code (or the corresponding provisions of any future of any United States Internal Revenue Laws).

ARTICLE VII - DISSOLUTION

Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all its assets exclusively for the purpose of the corporation in such manner or to such organizations organized and operated exclusively for charitable, educational, religious or scientific purpose as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code (or the corresponding provisions of any future of any United States Internal Revenue Laws) as the Board of Directors shall determine. Any such assets not disposed of shall be disposed of by the superior court of the county in which the principal office of the corporation is the located, exclusively for such purpose or to such organizations, as said Court shall determine, which are organized and operated exclusively for such purpose.

ARTICLE VIII - BOARD OF DIRECTORS

There shall be no less than six(6) Directors. The names and addresses of the persons who are to serve as Directors until the first annual meeting of Directors or until their successors are elected and qualified are as follows and these directors shall be elected by the dues paying members, & as is stated in the bylaws.
