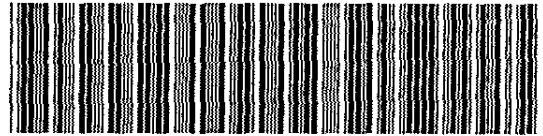

Articles of Incorporation
Of
Agape' Corner Boarding School and Ministries of Florida Inc.

The undersigned, a majority of whom are citizens of the United States, Desiring to form a Non- Profit Corporation under the Non- Profit Corporation Law of Florida, do hereby certify:

FIRST: The name of the Corporation shall be AGAPE' CORNER BOARDING SCHOOL AND MINISTRIES OF FLORIDA, INC.

SECOND: The place in this State where the principle office of the Corporation is to be located is the City of Bradenton, Manatee County.

THIRD: Said Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c) 3 of the Internal Revenue Code of 1054 (or the corresponding provision of any future United States Internal Revenue Law).

FOURTH: The names and Addresses of the persons who are the initial Trustees of the Corporation are as follows:

FIFTH: No part of the net earnings of the Corporation shall insure to the benefits of, or be distributable to its members, trustee, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in Article Third hereof. No substantial part of the activities of the Corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statement) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not

carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

SIXTH: In the event of dissolution, Agape' Corner Boarding School and Ministries of Florida, Inc., an exempt Corporation under Section 501 (c) 3 of the Internal Revenue Code will distribute any remaining assets to Agape' Corner Inc., of North Carolina an exempt corporation under Section 501 (c) 3 of the Internal Revenue Code or to any other exempt organization under Section 501 (c) 3 of the Internal Revenue Code as designated by the Board of Trustees. In no event will assets, upon dissolution, be distributed to the members or shareholders.

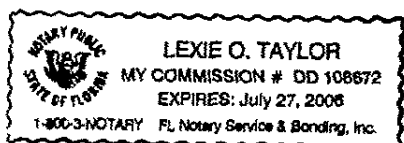
