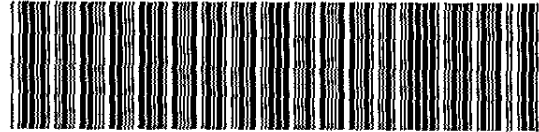

Notwithstanding any other provision of these articles, this Corporation will not carry on any other activities not permitted to be carried on by (a) a Corporation exempt from Federal income tax under section 501c (3) of the internal revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law of (b) a corporation contributions to which are deductible under section 170 c (2) of the Internal Revenue Code of 2954 or any other corresponding provision of any future United States Internal Revenue Law.
