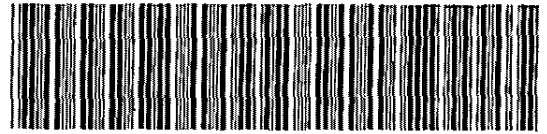

ARTICLES OF INCORPORATION
In Compliance with Chapter 617, F.S., (Not for Profit)

We, the undersigned, come together for the purpose of forming a corporation not for profit under Chapter 617, Laws of the State of Florida, providing for the formation, liability, rights, privileges, and immunities of a corporation not for profit.

ARTICLE I
NAME

The name of this corporation shall be Zoe Worldwide Ministries, Inc.

ARTICLE II

ARTICLE III
PURPOSE

The purposes for which this corporation is formed are:

A. Religious, charitable, scientific, literary, or educational, within the meaning of Section 501 (c) f the Internal Revenue Code as now in effect or as it may be amended. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(C)(3) of the Internal Revenue Code of 1986 (or the

corresponding provision of any future United States Internal Revenue Law), or by a corporation, contributions to which are deductible under Section 170(C)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

B. To operate, manage, run, and otherwise do and perform those acts and things appropriate and proper for the conduct of educational, evangelistic, and disciplinary functions of a church and/or other missionary type of organization as an entry point for persons into the ministry and a personal relationship with Jesus Christ, and to assist in improving the moral and spiritual conditions of humanity.

C. To sell such literature, including books, pamphlets, newsletters, and audio tapes, video tapes, CD's, and/or any other facets of multi-media, that in the opinion of the Board of Directors would be for the furtherance of the corporation's purposes and causes.

D. To receive love offerings and contributions, to receive, manage, take and hold real, personal and/or mixed property by gift, grant, devise, or bequest, and to sell or dispose of the same for the benefit of this corporation.

E. To purchase or sell, hypothecate, mortgage, and lease such real and personal property as may be necessary for the purposes of the corporation, and to execute deeds, contracts, agreements and obligations, the purposes whereof are consonant with the laws of the State of Florida under which this corporation is formed, and to accept and execute any trust, the purpose whereof is lawful under said laws and consistent with the purposes of this corporation; and to do each and everything necessary, suitable, or proper for the accomplishment of any of the purposes herein enumerated, or which may at any time appear conducive or expedient for the benefit or protection of this corporation.

F. This corporation shall have no capital stock, no dividends shall ever be declared or profits distributed, and no part of the net earnings of the corporation shall be distributed to, used for, or inure to the benefit of any private officer, trustee, director, or individual, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. The corporation shall not carry on propaganda, or otherwise attempt to influence legislation, or intervene in any political campaign on behalf of any candidate for public office.

ARTICLE IV MANNER OF ELECTION

A Board of Directors, consisting of not less than (3) three persons, shall have the general management and control of the affairs of the corporation, and shall exercise all powers that may be exercised or performed by the corporation under these Articles, the By-Laws of the corporation, and the statutes of the State of Florida. The directors of the corporation, with the exception of the initial Board of Directors specified below, shall be

elected in the manner set forth in the By-Laws of the corporation. Future directors shall be elected at the first annual meeting of the Board of Directors, and shall serve for a term designated by the By-laws. Annual meetings shall be held each year at such time and place that may be designated by resolution.

The Board of Directors shall elect the following officers: President, Vice-President, Secretary, and Treasurer, and such other officers as the By-Laws of this corporation may authorize the Directors to elect from time to time.
