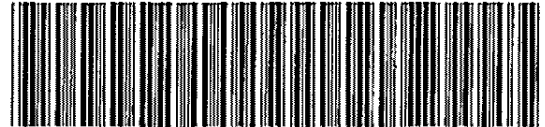

**ARTICLE I - NAME**

The name of the organization is The Eagle's View Athletic Booster Club, Inc.

**ARTICLE III - PURPOSE/MISSION STATEMENT**

The club will be a nonpartisan, non-sectarian, and nonprofit organization whose members will have the sole right to govern and control all of its activities through elective officers. The Club is organized not-for-profit and no part of the net earnings will inure to the benefit of any member. Any funds generated by the Club will be used for promotion of the objectives of this organization.

The Mission by which EVABC will govern its activities is as follow:

- a. To support the Eagle's View Academy athletics program in all their endeavors, including social and charitable events that support the programs.
- b. To support Eagle's View Academy scholastic and religious approach to developing and enhancing the athlete's cultural environment while attending EVA and beyond.
- c. To provide education and information about the EVABC and the Academy to the membership and the public.
- d. To encourage and promote good relationships between Eagle's View Academy, the Duval County School System, and other schools with which Eagle's View Academy may engage.

**ARTICLE IV - MANNER OF ELECTION**

The property, business, finances, and affairs of the EVABC will be managed and controlled by the Board of Directors that consists of a President, Vice President, Treasurer, Secretary and Athletic Director.

The President, Vice President, Treasurer, and Secretary are the elected officers of the EVABC and will be elected at the last general membership meeting of the fiscal year. They shall serve for a period of one year or until their successors are elected or appointed. No members will be eligible to serve more than four consecutive terms in the same office. The newly elected officers will assume their responsibilities at the first meeting of the year or after August 1st. Nominations will come from the floor followed by a second or from the Nomination Committee. The nomination list will be read by the Vice President and approved by a motion and a second of the members in attendance. A move to close nominations and a second must be made before voting can take place. All voting will be made by secret ballot

or a show of hands being counted, with *individual memberships receiving one-vote and family memberships receiving two votes*. The results will be made public immediately. The President will be the first officer elected followed by the vice-president, secretary, and treasure.

**A. Nominations:**

1. All nominees for the Board position must be at least 21 years of age.
2. All nominees must have been an active member of the club for at least two (2) years and have attended a majority of the meetings in the two years prior to nomination.
3. All nominations will come from the floor at the last meeting in the present year and/or from the Nominating committee, if appointed.
4. Members of an immediate family may not be nominated for a Board Member positions. Immediate family is defined as blood relatives and/or relatives by marriage that may or may not be living under the same roof.

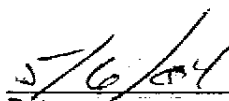

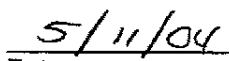
