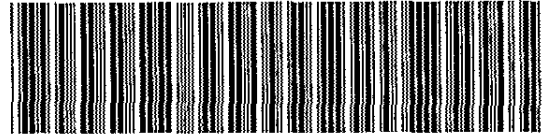

ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLES I NAME

The name of the corporation shall be:

ARTICLES II PRINCIPLE OFFICE

Article III Purpose

The purpose for which the corporation is organized is: *to operate exclusively for Religion, Charity, Educational and Distinct Ecclesiastical purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986. To Conduct Religious and Educational Activities - To Conduct Church services, and Church Activities - To Organize and develop a multidisciplinary Center to Conduct Classes and Child.*

A. The purpose for which this organization is organized are exclusively religious, charitable, ~~Scientific~~ scientific, literacy and educational within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

B. Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

C. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or shall be distributed to the Federal, state, or local government for a public purpose. Any such assets not so disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.
